Dear Mr. Hemmerle:

This is an update to my Program Letter notifying you of a change of home base and additions to my current list of aviation events in your service area scheduled for 2014. 2015 events will be added with a new update January 1, 2015.

In accordance with 4130(c):

*c. Home Base Changes or Ownership Transfers. When an aircraft's home base is changed or there is a transfer of ownership, the owner/operator must notify the local FSDO having jurisdiction over the area in which the aircraft will be based within 30 days*

*(2) The gaining FSDO will not require the aircraft's special airworthiness certificate and operating limitations to be reissued, unless the aircraft is in Phase I test flight operations, the current limitations require reissuance, or the owner requests reissuance or amendment. N493JM is in phase II.*

*(4) Copies of the aircraft registration, special airworthiness certificate, and operating limitations are on file with the FAA Aircraft Registration Branch, and the aircraft owner does not need to provide copies to the gaining FSDO.*

*(d) Existing Airworthiness Certificates and Operating Limitations. All previously issued airworthiness certificates and operating limitations will remain valid unless changes are requested by the applicant or reexamined by the FAA in accordance with 49U.S.C.44709.*
